  - X Kadcyla (T-DM1)
    - » Roche (August)
    - » PHARMAC (December)
  - - » AstraZeneca (November)
    - » PHARMAC (early-mid 2020)



- A CDK 4/6 inhibitor to be provided first and second line:
   palbociclib (Ibrance, Pfizer), ribociclib (Kisqali, Novartis)
   or abemaciclib (Verzenio, Lilly)
  - » Pfizer or Novartis (?)
  - » PHARMAC (RFP; April 2020)

# Engaging with DHBs to eliminate inequity

- X July 2018 Irene wrote on behalf of BCAC to the Chairs of Counties-Manukau and Auckland DHBs about the lack of provision of chemo at Middlemore Hospital
- X Oct 2018 − BCAC met with Pat Snedden Chair ADHB, Richard Sullivan − of Auckland Blood and Cancer Services and others. Snedden asked for our input
- Nov 2018 Fay and others wrote a discussion paper: How can ADHB achieve greater equity and improved outcomes for Māori and Pasifika breast cancer patients and how could BCAC assist?
- ★ Feb 2019 met again with ADHB oncologists Richard Sullivan, Fritha Hanning, Sheridan Wilson
- ★ April 2019 Irene wrote to Margie Apa, CEO CMDHB
- May 2019 Apa replied describing significant improvement in services...and ongoing commitment
- Progress! And continuing engagement

This pattern is repeated within advanced breast cancer (ABC), which is the focus of this paper,3 Research commisstoned by the Ereast Concer Foundation New Zealand found Māori women in Aoteacoa with a diagnosis of ABC (stage IV) have a 5% five year survival rates while New Zealand European women have a 15% survival cate.4 The evidence suggests these rates persist even when all factors except ethnicity are controlled for FAs Wiki Mulhelland, while edvocating on behalf of women with ABC, highlighted in her 13 March 2019 Health Select Committee submission, we need to recognice that Maori women are the heart of the whines and wider community and we need to keep them well.

Through to Tiriti o Westergy, asternational human rights agreements and core health policy and legislation, the New Zealand Government has an obligation to protect and promote Maori health and pursue health equity.47 Systemic ethnic inequities in cancer outcomes suggest a failure of the Ministry of Realth in its role of stewardship.2 If, as the data suggest, all other factors are controlled for and ethnic inequities percist, we argue it is likely to be institutional racism-a pattern of behaviour that benefits one ethnic group and disadvantages another. Institu tional racism can manifest through policy investment decisions, mono-cultural structures and inaction. Critically, racism does not need to be intentional.




