CHAIRPERSON'S REPORT





This year we celebrate BCAC's tenth anniversary so let's take a moment to reflect on where BCAC stands in 2014. We have come a huge distance in the ten years since our 12 founding member groups met in 2004 to establish a clear and credible voice for New Zealanders diagnosed with breast cancer.

Since then, our membership has expanded to include more than 30 diverse groups as well as individuals throughout the country. This ensures

we are closely connected to the 3,000 New Zealanders diagnosed with breast cancer each year, giving us a real-time view of the experiences of those diagnosed and treated today. Through these links we are able to identify and understand the issues that patients experience in the health system. Our close ties with oncologists, surgeons and breast care nurses provide us with the expert view of life at the breast cancer coalface.

Over time, BCAC has also developed strong relationships with the Minister of Health, the Ministry and other decision-making groups and it is gratifying to know that BCAC has come to be recognized by these bodies as providing credible and reliable patient/consumer representation. This ensures we have a direct line to those who have the power to solve problems and provide solutions for those facing difficulties. We have worked hard to ensure consumer representation in policy and decision-making groups and have made significant ground in achieving our early aim of establishing "seats at the table". We need to ensure we continue to develop knowledgeable advocates to fill these roles effectively.

We have built a strong, evidence-based platform from which to advocate for access to world-class treatment and care by ensuring our representatives are well educated in the science as well as the politics of breast cancer. We have had some notable successes, securing funding for Herceptin in 2008 and having a hand in bringing taxanes, aromatase inhibitors and other medicines to patients.



BCAC has also played a significant role in establishing best practice guidelines and more recently *Standards of Service Provision for Breast Cancer Patients in NZ.*

The Australia and New Zealand Breast Cancer Trials Group (ANZBCTG) held its annual meeting in Wellington this year and it was marvellous to see a record number of kiwi advocates attend. If we are to be effective advocates for world-class detection, treatment and care for breast cancer in NZ, it is vital that we understand the biology of the disease as well as the clinical trials process. These are the studies that lead to breakthrough treatments that can offer improved quality of life and better survival.

We were delighted to be able to send a representative to the C4YW conference for young women in Florida and two women to the Breast Cancer Network Australia's advocacy and science training course in Melbourne.

This year we discovered that the three northern DHBs were refusing to provide funded medicines to cancer patients who chose to additionally access unfunded treatments in the private sector. As an example of the impact of this policy, those with advanced HER2 positive breast cancer wanting to access the dramatic survival benefits of Perjeta would not only have to pay the high cost for the new drug, but also pay for their Herceptin that would be funded for all other patients. We raised this in a special meeting with the Minister who determined that these DHBs were acting illegally and he promised to fix this.

We were approached by women insured with Sovereign who were told they could spend no more than \$20,000 on breast reconstruction. We met with Sovereign's CEO and Claims Manager to explain that this was a completely inadequate amount and as a result they revised and modernized their policy conditions to allow reimbursement of all reasonable costs.



The Rotorua Breast Cancer Trust put us in touch with a woman who had been told by the Waikato DHB that, given their limited capacity, her delayed breast reconstruction was of such low priority that she would not even be put onto a surgical waiting list. We facilitated media coverage and raised this with the Ministry of Health and have recently been told that the Ministry's Elective Surgery Group will deal directly with the DHB to find a solution for those affected.

We applied to the National Health Committee to introduce Intrabeam radiotherapy into our public health system and further supported this innovative technology in a submission to the Royal Australian and New Zealand College of Radiation Oncology. Intrabeam delivers a single shot of radiation into the tumour bed during initial breast cancer surgery. It offers a fantastic option for women with low-risk early breast cancer, providing effective treatment in a localized area, avoiding damage to other tissues and eliminating the need for repeated visits to the radiology clinic over several weeks. We look forward to wide adoption of Intrabeam for appropriately selected patients.

Another highlight from this year has been the revision of BCAC's much loved *Step by Step* support pack and we have produced 5,000 copies of the new 3rd edition. We have expanded *Step by Step* to include sections on dealing with the emotional fallout of a diagnosis, sexuality and intimacy, fertility, men with breast cancer and self care. We were delighted to welcome the New Zealand Breast Cancer Foundation as principal sponsor for the new edition.

Despite our successes there's still much to achieve. Recent data shows that New Zealand's cancer mortality remains 15% higher in NZ women compared to Australian women. Outcomes are still worse for Māori and Pasifika women than for those of other ethnic groups. New highly effective medicines are emerging but they come with a high price tag and it will be challenging to get these funded to allow patients to access the benefits in improved quality and length of life.



US statistics tell us that despite recent improvements in 5 and 10-year survival rates, around a third of those diagnosed will eventually develop advanced disease. There is now a strong international push to focus more research on treatments that will make a real difference for those with metastatic breast cancer.

For kiwis with metastatic breast cancer, BCAC is thrilled to have been able to establish Metavivors NZ earlier this year and watch it grow into a thriving Facebook-based community where participants offer mutual support and empowerment through shared experiences. The group is also proving to be a great information and knowledge-sharing platform. Recently, Metavivor NZ members have been working closely with BCAC to seek access to innovative medicines.

To all BCAC's members and supporters, thanks so much for your wonderful input! Without your passion, commitment and collaboration we couldn't have achieved so much for New Zealanders with breast cancer so please continue to stand and work with us to help make the future brighter for everyone diagnosed.



GOAL 1: Supplying information and resources

- Revised, re-wrote and edited a new edition of BCAC's Step by Step support pack following consultation with medical professionals, BCAC member groups and others in the breast cancer sector.
- Delivered Step by Step support packs free of charge to more than 1300 women newly diagnosed with breast cancer in New Zealand.
- Provided up-to-date information on breast cancer diagnosis, treatment and recovery, along with the latest research results and regular weekly news items on the BCAC website, Facebook page and Twitter.
- Achieved a 58% increase in the number of visits to the BCAC website compared with 2013.
- Promoted the BCAC web videos, Kiwi Stories of Breast Cancer which have been viewed by more than 8,850 people on our website and Youtube.
- Responded to queries posted from women with breast cancer on our Facebook page and through the BCAC website.



GOAL 2: Providing a voice for those diagnosed with breast cancer

- Appealed to the Minister of Health when a NZ cancer treatment centre was found to be refusing publicly funded medicines to patients who were accessing additional medicines in the private sector. The Minister commented that the DHBs involved were failing to meet their legal requirements and promised to resolve the issue.
- Worked on behalf of women with breast cancer who experienced trouble negotiating the health system to ensure their needs were met and that they received appropriate treatment and care.
- Established an online support group called 'MetavivorsNZ' for New Zealanders with metastatic breast cancer. The group is very active and membership is increasing weekly.
- Appealed to the National Ethics Advisory Committee (NEAC) to establish effective mechanisms to review the safety and ethical status of clinical trials operating in New Zealand. BCAC has had input into a review of cross-sectoral ethics arrangements which is currently underway by NEAC.
- Briefed the Minister of Health and other key politicians on the need to improve services for New Zealanders with breast cancer, in particular, faster cancer treatment (especially in rural areas and where patients are managed across multiple DHBs), access to delayed breast reconstruction, counselling, lymphoedema management, fertility treatment for young women diagnosed and ensuring optimal treatment and care for elderly patients.











GOAL 3: Informing and advocating for access to worldclass detection, treatment and care

- Continued to push for an expansion of the upper age limit for BreastScreen Aotearoa's free screening programme from 70 to 74, as has happened in Australia.
- Made submissions to PHARMAC to fund the breast cancer drugs Abraxane, Perjeta and Kadcyla.
- Worked with Sovereign Insurance to improve policy conditions for women receiving breast reconstructions.
- Lobbied the National Health Committee and the Royal Australian and NZ College of Radiologists to bring the Intrabeam radiotherapy technology into the pubic health system in New Zealand.
- Submitted information to be included in the Ministry of Health Cancer Information Strategy document.
- Highlighted a range of breast cancer clinical trials available in New Zealand through the BCAC website and newsletter.
- Participated in NZ Breast Cancer Special Interest Group meetings, the Australian New Zealand Breast Cancer Trials Group conference and the C4YW International Conference for Young Women with breast cancer. Attended and sponsored Shocking Pink to attend BCNA's breast cancer science and advocacy training course in Melbourne.



GOAL 4: Working to improve outcomes for Māori and Pasifika women diagnosed with breast cancer

- Liaised with Māori and Pasifika women affected by breast cancer and with related advisory groups.
- Supported and promoted BreastScreen Aotearoa's commitment to increase screening rates for Māori and Pasifika women.
- Supported Wahine Toa, a group for Māori and Pasifika women with breast cancer.





BCAC's Step by Step Support Pack



In 2014 we delivered the *Step by Step* support pack, including our new 3rd edition, to more than 1300 women with breast cancer throughout New Zealand - here's what they had to say about it:

After a Waikato woman was told her delayed breast reconstruction was too low a priority to be on a waiting list, BCAC raised the issue with the Ministry of Health and obtained media coverage for her. We received the following message:

"Huge thanks also to Libby, Nic and the BCAC team for your amazing support and work on this situation to date."

BCAC was approached by women insured with Sovereign who were told they could spend no more than \$20,000 on breast reconstruction. Following a meeting we had with them they revised their policy conditions to allow reimbursement of all reasonable costs. Below is a response we received from one of those women:

"WAHOO - got a phone call from Sovereign last night with the good news that they will reimburse my expenses for reconstruction!!!!! I'm more happy that finally there have been some policy changes that will benefit other women going through the same thing... please can you pass on my heartfelt thanks to Libby for her going into battle on this issue. 

Plans for 2015



In 2015 we plan to continue working on BCAC's Key Initiatives:

- 1) To <u>support and empower</u> New Zealanders diagnosed with breast cancer and their family, whanau and friends, by providing information and resources to enable women to make well-informed choices about their treatment and care by:
 - offering Step by Step to every New Zealander diagnosed with breast cancer
 - regularly updating the BCAC website at <u>www.breastcancer.org.nz</u>, our Facebook page and Twitter account
 - promoting our Kiwi Stories of Breast Cancer web videos, and
 - responding to requests for information and advice
- 2) To provide a <u>unified</u>, <u>evidence-based voice</u> for New Zealanders diagnosed with breast cancer; and to inform and advocate for timely access to world class breast cancer care,including treatments (surgery, medicines, radiotherapy, management of side-effects, self-care) and psychosocial care throughout New Zealand by:
 - promoting the implementation and monitoring of the Ministry of Health's Standards of Service Provision for Breast Cancer Patients in New Zealand throughout the country
 - involvement in a wide range of local, regional and national breast cancer related working groups, committees and organisations
 - meeting with the Minister of Health, Ministry leaders in cancer projects, BreastScreen Aotearoa, Cancer Control NZ, PHARMAC, Medicines NZ and other relevant individuals and groups
 - responding to consultation opportunities relating to breast cancer



Plans for 2015 cont'd

- working with PHARMAC, pharmaceutical companies and others to secure funding for effective new breast cancer medicines (including Perjeta, Kadcyla and Abraxane)
- increasing education and knowledge of breast cancer, treatments and supportive care and emerging clinical trial results by attending and promoting local and international expert meetings and conferences
- promoting consumer input into cancer related initiatives and policy making
- engaging in and facilitating networking and collaboration among breast cancer groups and affected individuals
- 3) To consult and engage with <u>Māori and Pasifika</u> women to identify and promote breast cancer issues that could improve outcomes in these communities by:
 - supporting and promoting opportunities for consultation and engagement
 - promoting the messages received from Māori and Pasifika women to policy and decision makers
 - raising awareness of current inequities in breast cancer incidence, access to services and outcomes
- 4) To support and promote initiatives enabling the <u>early detection</u> of breast cancer such as mammography screening and breast awareness by:
 - meeting regularly with BreastScreen Aotearoa to discuss progress with the national screening programme
 - providing information and comment on the most effective ways to achieve early detection



Plans for 2015 cont'd

- 5) To promote the collection of high quality <u>breast cancer data</u> to enable clear understanding of the characteristics of the disease and impacts of particular treatments at defined types/ stages on outcomes by:
 - clarifying the value and importance of detailed Breast Cancer
 Registers to the Minister and Ministry of Health and others
 - having input to the Ministry's Cancer Information Strategy
- 6) To support the activities of BCAC by:
 - promotion and fundraising












