

Chair Report



This year, while continuing to represent all New Zealanders with breast cancer on a range of issues, BCAC has focused on making a difference for Kiwis with advanced breast cancer (ABC).

This vital area has received too little attention over the years and it's time for that to change. We have continued to support Metavivors NZ, a Facebook-based group for Kiwis with ABC that is going from strength to strength. Our partnership with the Karen Louisa Foundation (KLF) has enabled BCAC to progress a number of initiatives including: the development of Metavivors videos (now live), a poster and a brochure (soon to be released). The Sweet Louise/NZ Breast Cancer Foundation ABC forum, with its themes of knowledge, support and empowerment, was inspirational. I presented ideas on the Power of Advocacy in Improving Cancer Care, noting that silent issues receive no attention.

BCAC was delighted that ten conference attendees were happy to share their stories on video to help us raise awareness of ABC. We have also made a compilation video of our brave Metavivors commenting on the dire lack of access to modern medicines faced by Kiwis with ABC. We're using this awesome video as the key driver in our current campaign for better access to breast cancer medicines. The campaign aims to inform the public and persuade the Minister of Health to fund more medicines by bringing New Zealand's investment closer to the OECD average. As it stands NZ invests the least of all OECD countries, has the worst access to medicines and shockingly, we have a breast cancer death rate 40% higher than Australia's.

Over the year, we have had regular meetings with the Ministry of Health's Cancer Team, BreastScreen Aotearoa and other Ministry officials. Discussions included access to breast reconstruction, screening coverage, faster cancer treatment, Intrabeam Intra-Operative Radiotherapy, Mepitel film for reducing radiation burns, medicines needed and clinical trial access. This year BCAC will brief the Minister on a range of breast cancer issues in early December.

It was great to see BCAC members continuing to learn about the biology of breast cancer as well as the latest medicines, surgical techniques, radiation technologies and biomarker development at national and international conferences and meetings. This education is essential in ensuring BCAC's advocacy remains solidly evidence-based.

BCAC provided a credible consumer voice across the health system on a wide range of issues. We educated clinicians and officials about the value of engaged consumers in delivering high quality healthcare and informed GPs of the qualities and behaviours required in an effective GP. We continued our involvement with expert clinical groups and committee members were recruited into new consumer representative roles relating to clinical trials.

Our efforts continue to ensure New Zealanders with breast cancer have access to world-class medicines, technologies, techniques and care. We are also working hard to establish better access to clinical trials.

We were pleased to collaborate directly with BCAC member groups on specific projects and to see other groups working together as well.

Many women approached BCAC for guidance and support during the year and we were delighted to assist.

Thanks so much to all our members and supporters and to the experts we have worked with and learned from during the year. Special thanks to all the women who have come to BCAC for support and information, and to raise issues they have faced during their diagnosis, treatment and recovery. This contact has enabled us to identify the key issues facing New Zealanders diagnosed with breast cancer so we can engage with officials and policy-makers to address problems and find solutions.

- Delivered more than 1,200 Step by Step support packs to New Zealanders newly diagnosed with breast cancer.
- Produced a series of videos highlighting the experience of New Zealanders with advanced breast cancer.
- Created an online video advocating for better access to medicines for Kiwis with advanced breast cancer.
- Provided information on breast cancer diagnosis, treatment and recovery via our website www.breastcancer.org.nz.
- Delivered up-to-date breast cancer news, research results and events via our website, Facebook page, and Twitter account.
- Supported more than 1,900 New Zealanders through the BCAC Facebook page.
- Supported more than 160 New Zealanders with advanced breast cancer through the online community, Metavivors NZ.
- Designed a brochure and poster to promote Metavivors NZ.
- Distributed an e-newsletter with relevant breast cancer news and information to hundreds of registered members and others.
- Responded to 50+ queries through the BCAC website and Facebook page.



- Providing a voice for those diagnosed with breast cancer
- Launched a campaign highlighting the desperate need for better access to medicines in New Zealand, including:
 o an online video stressing the need for better access to medicines
 o a series of videos featuring Kiwis with secondary breast cancer
 o a direct email campaign to the Minister of Health on the issue
 o widespread media coverage of the issue.
- Delivered more than 1,700 submissions to the Minister of Health highlighting the need for better access to medicines.
- Supported women with breast cancer to negotiate the health system and secure timely and appropriate treatment and care.
- Presented at the Advanced Breast Cancer Symposium: *BCAC and Metavivors: The Power of Advocacy in Improving Cancer Care.*
- Presented to the Health Safety and Quality Commission Forum on Clinical Leadership: *Valuing Empowered Consumers*.
- BCAC member Melissa Bell appointed as a consumer representative on the Australian New Zealand Breast Cancer Clinical Trials Group.
- BCAC member Emma Crowley appointed to the Consumer Advisory Panel of Clinical Trials New Zealand.



- Improving access to world-class treatment and care
- Made a joint submission with the Breast Cancer Network Australia supporting the introduction of intra-operative radiotherapy into the public health system.
- Wrote to the Minister of Health advocating for the introduction of intra-operative radiotherapy in the public health system.
- Engaged with Southern Cross Healthcare to follow other health insurance companies and reimburse policy holders for intra-operative radiotherapy treatment.
- Made a submission on the New Zealand Health Research Strategy.
- Presented to the Royal New Zealand College of General Practitioners: Your Partnership Promise - A Patient Perspective.
- Lobbied pharmaceutical company Roche, to offer Perjeta, Kadcyla and sub-cutaneous Herceptin to Pharmac at affordable prices.
- Had quarterly meetings with the Ministry of Health's Cancer Team to seek improvements and action on issues for breast cancer patients.
- Highlighted breast cancer clinical trials available in New Zealand.
- Represented New Zealanders with breast cancer at key international conferences.



- Improving outcomes for Māori and Pasifika women
- Liaised with Māori and Pasifika women affected by breast cancer and related advisory groups.
- Highlighted the poorer outcomes of Māori women with breast cancer with a series of website articles.
- Appealed to BreastScreen Aotearoa, the Ministry of Health's Cancer Team, and the Minister of Health to achieve real and significant improvements in the speed of detection and treatment for Māori women with breast cancer.

Plans for 2017

1. Make world class detection, treatment and care accessible to all affected by breast cancer in New Zealand

- Quarterly Ministry of Health liaison
- Raise awareness of new and emerging medicines
- Increase education and knowledge of breast cancer, treatments and supportive care and emerging clinical trial results by attending and promoting local and international expert meetings and conferences
- Increase access to clinical trials
- Meet pharmaceutical companies and encourage them to register their innovative medicines in New Zealand and to offer them at affordable prices
- Engage and facilitate networking and collaboration among groups and individuals
- Brief the Minister of Health
 - Promote consumer related initiatives and policy making
 - Medicines access, clinical trials, safety of ethical trials
 - Breast Cancer Standards to be implemented
- Highlight inequities in timely treatments and poorer health outcomes for Māori women with breast cancer
- Promote the collection of high quality breast cancer data
- Consult and engage with Māori and Pasifika women to identify and promote breast cancer issues that could improve outcomes in these communities by:
 - Supporting opportunities for consultation and engagement
 - Promoting the messages received from Māori and Pasifika women
 - Raising awareness of current inequities in breast cancer incidence, access to services and outcomes.
- Meet with Pharmac regarding access to innovative medicines.

2. To provide information and support to empower those with breast cancer to make informed choices about their treatment and care

3. To provide a unified evidence-based voice for New Zealanders who have experienced breast cancer

- Advocate for timely access to world class breast care, including treatments and psychological care in NZ


