Chairperson's Report

We've had another challenging year in which our lives and activities have been hugely disrupted by Covid and related restrictions. Online platforms have been vital in reaching out, maintaining connections with each other and continuing our work. The rare opportunities to meet and collaborate in person have been precious.

A big concern as Covid cases begin to rise, is how our health system will be able to provide timely cancer services. The BreastScreen Aotearoa (BSA) screening programme was halted at Alert Level 4 and is slowed during Levels 3 and 2. BCAC fully supports the Breast Cancer Foundation's (BCF) call to find the 133 women who have undetected breast cancer as a result of these delays. BCF's petition calls for the Government to: provide the funding and resources to process the backlog within six months; ensure breast screening continues during all lockdown levels; restore and extend the BSA programme to the 70% agreed target for ages 45 – 69 and extend coverage to 70-74 years; add breast screening participation as a measured indicator in our health system. Please visit BCAC's or BCF's website to sign the petition.

We know that many other cancer procedures have also been delayed by Covid, including diagnostic scans, surgery and many other treatment services. Urgent action is needed to provide the resources to restore cancer services to allow the best outcomes for those affected. BCAC has collaborated with other cancer patient groups to promote the New Normal Same Cancer campaign to encourage everyone to treat cancer with the urgency it deserves. While responsibility for ensuring our health system functions effectively clearly rests with the Government and the Ministry of Health there is much we can do as individuals to protect ourselves. Vaccination is absolutely top of the list. Please protect yourself and your whānau by becoming fully vaccinated. Those of us receiving cancer treatments that compromise our immune systems, such as chemotherapy, are now eligible for extra protection through a third vaccination. Talk to your specialist or GP about this. Third doses can be given eight weeks after the second shot with a doctor's prescription. If you've had a mammogram, diagnostic test, scan or cancer treatment delayed, please do everything you can to rebook and get medical attention as soon as possible. Meanwhile, mask up and stay safe!

The biggest highlight for me this year was the time I spent with an amazing group of Metavivors, filming more of our *Gifts to the Future He Koha ā Mua* videos. Those warm February days were filled with laughter and positivity as these lovely, articulate women shared the stories of their advanced breast cancer. They came together from around Aotearoa to pass on their experiences and wisdom as an enduring gift to others. We will forever appreciate the generosity and courage of these delightful women. Jane Reeves, also a Metavivor, was our wonderfully empathetic and professional interviewer. Sadly, Jane passed away in September, moe mai rā e hoa. We will remember Jane with enduring aroha. The Metavivors NZ Facebook group has continued to be a fantastic peer-support zone and we're incredibly grateful to our committee member Terre Nicholson for the love, energy and wisdom she continues to pour into the group. Thanks to all the other wahine toa who contribute to the group and to Sweet Louise, the charity that provides direct support to those with advanced breast cancer.

During the year a new online group emerged that has become an excellent source of information and support for those diagnosed with breast cancer. Belinda Tran-Lawrence established the Aotearoa New Zealand Breast Cancer Community on Facebook and with Belinda's great communication skills, warmth and energy it has grown to be a welcoming and safe space to share experiences, thoughts and tips. We're delighted that the group has recently joined BCAC, further strengthening our broad coalition.

The BCAC committee and members attended many online breast cancer conferences this year. In a way it was convenient to hear the latest results and news without having to fly to another city or country, although we did miss the face-to-face networking. Clinical trials around the world have revealed some important advances in the use of innovative immunotherapies for breast cancer this year, with breakthroughs in treating both metastatic triple negative and HER2 positive breast cancers. As new treatments are shown to extend and save lives the future is full of hope that breast cancer will become a much more treatable and less deadly disease.

We look forward to a time when New Zealanders have greater opportunity to participate in clinical trials and to have faster access to modern medicines. BCAC is pleased to be involved in two related projects seeking to enhance clinical trial availability in Aotearoa, one led by the Ministry of Health and the other by University of Auckland. We are hopeful that these will lead to significant advancement to provide early access to innovative treatments for our women.

BCAC joined Patient Voice Aotearoa's Lie Down for Life events around the country to support the petition signed by over 100,000 New Zealanders to reform Pharmac and increase its budget. During the year we made a comprehensive written submission to the Pharmac Review Committee, and met with the committee both in person and online with other patient groups to discuss much needed reforms. We want to see an updated medicines funding model driven by aspiration to improve patient outcomes rather than by rationing and budgetary constraints. This should operate with greater speed and transparency and enable input from affected patients and their representatives. New Zealand should treat cancer patients with the medicines listed in international best practice guidelines rather than an outdated subset of these. We also responded to Pharmac's own consultations on its committee structures and its proposals to decline 'inactive' funding applications. We disputed the deletion of two breast cancer medicines on the decline list, noted that there are more effective modern versions of a

third medicine on that list and have written to oppose the separate decline of a fourth medicine. The positives are that Pharmac has shown more transparency in its intentions to decline medicines and is planning to increase input from its Consumer Advisory Committee. It will be vital that appointees to that committee are informed by patients needing a medicine under consideration and the groups that represent them.

We were pleased to have input into new draft guidelines from the Ministry of Health on breast reconstruction surgery. Once these are in place all breast cancer patients wherever they live in Aotearoa should be offered all the available surgical options. We certainly hope these guidelines don't suffer the fate of previous breast cancerrelated guidelines that we have contributed to, which ended up gathering dust and never being implemented.

Back in March we briefed the Health Minister Andrew Little and Diana Sarfati, CEO of the Cancer Control Agency Te Aho o Te Kahu, on key issues facing the breast cancer community in Aotearoa. Input from across our member groups provided insight into the issues faced by women at the coalface of breast cancer and opportunities for improvement. We also highlighted three strategic areas that can deliver greater equity and better outcomes, namely: managing risk and better targeting screening; greater access to medicines; gene-based testing for greater precision in treatment.

I wish everyone inner strength, courage and joy as our resilience is tested in the coming months. There are many wonderful things to celebrate about our beautiful country, our diverse people and ourselves. Be gentle and loving to yourself and those around you and find pleasure in the small delights of everyday life.

Key Achievements in 2021

Information and resources

- Delivered more than 1250 Step by Step support packs to New Zealanders newly diagnosed with breast cancer. The COVID-19 pandemic again disrupted our efforts to distribute as many packs as we have in the past but with the vaccination programme well under way, we hope the lengthy disruptions to health services will ease.
- Provided information on breast cancer diagnosis, treatment and recovery via our website *www.breastcancer.org.nz*
- Delivered up-to-date breast cancer news, research results and events via our website, Facebook page and Twitter account.
- Delivered a regular e-newsletter to hundreds of registered members and others.
- Supported more than 2500 New Zealanders through BCAC's main Facebook page and more than 300 members in our Facebook group.
- Supported more than 400 New Zealanders with advanced breast cancer through the online communities Metavivors NZ and Metavivors NZ - Action.
- Responded to more than 50 queries through the BCAC website and Facebook page.

Providing a voice for those diagnosed with breast cancer

BCAC committee members participate in a number of consumer and specialist breast cancer groups throughout New Zealand to ensure breast cancer patients are represented in the health system. We also engage in other activities and projects designed to raise the voices of those diagnosed with breast cancer.

 Following the Government's decision early in 2021 to conduct an independent review of PHARMAC, BCAC attended a patient group meeting with the PHARMAC Review Panel in July 2021. The purpose of the meeting was for the Panel to gain insight into the experiences of consumers and patients in relation to the funding of medicines and interactions with PHARMAC.

- BCAC provides consumer representation on the Breast Special Interest Group (BSIG) of breast cancer specialists, with BCAC Chair Libby Burgess, Secretary Fay Sowerby and Treasurer Louise Malone all attending BSIG meetings this year.
- BCAC Deputy Chair Emma Crowley is Chair of the Consumer Advisory Panel of Cancer Trials New Zealand.
- Libby is a member of the NZ Cancer Control Agency's Te Aho o Te Kahu Consumer Reference Group, He Ara Tangata.
- Fay is a member of the Breast Cancer Trials (BCT) Fundraising and Communications Committee.
- Fay and Libby are consumer representatives on the New Zealand Familial Breast and Ovarian Cancer (NZFBOC) Group.
- Libby, Emma, Louise, Fay, Lynda Ames and Rowena Mortimer are members of Breast Cancer Trials' IMPACT Advocacy group and Libby is also an Associate Member of BCT.
- BCAC members attended the international Virtual Global Breast Cancer Advocacy Summit and Patient Advocacy Exchange online meetings.
- BCAC Committee member Rowena Mortimer is Chair of the Consumer Advisory Panel of the Health Quality and Safety Commission.

Prior to this meeting, BCAC made a comprehensive submission to the Review Panel outlining our experiences, concerns and suggested reforms.

- In May 2021 at the Lie down for Life events held throughout New Zealand, BCAC supported the presentation of Patient Voice Aotearoa (PVA) - He Reo Tūroro o Aotearoa's petition calling for a review of PHARMAC and the medicines budget. PVA advocates for medicines and other improvements in the health system across a wide range of disease groups, including breast cancer.
- In collaboration with Metavivors NZ, Sweet Louise and the Breast Cancer Foundation NZ, BCAC produced 16 videos for the Gifts to the Future, He Koha ā Mua Legacy Project for those with advanced breast cancer. These videos enabled a number of New Zealanders with advanced breast cancer to create video legacies recording moments, memories, messages and insights they wanted to share. The videos are a hugely valuable resource for others facing a similar diagnosis.









- BCAC is a member of the ABC Global Alliance, a European-based organization dedicated to improving and extending the lives of women and men living with advanced breast cancer worldwide. Committee members attended the virtual Advanced Breast Cancer 6th International Consensus Conference (ABC6).
- BCAC supported many women as they negotiated the health system to secure timely and appropriate diagnosis, treatment and care.

Improving access to world class treatment and care

 Early in 2021, BCAC met with Minister of Health, Hon. Andrew Little and Prof. Diana Sarfati, CEO of Te Aho o Te Kahu, the Cancer Control Agency. We presented a comprehensive briefing and identified three key issues with solutions we believe will make a big difference to the lives of New Zealanders with breast cancer and bring



greater equity to our health system. These issues were: managing risk and better targeting screening; greater access to medicines; and gene-based testing for greater precision treatment.

- Input for this meeting from across BCAC's 30+ member groups enabled us to provide insight to the Minister and Prof. Sarfati into many coalface issues that women with breast cancer face, revealing real opportunities for improvement.
- We met separately with politicians from other political parties to deliver our briefing.
- As part of BCAC's ongoing commitment to improving access to medicines, we provided a response to PHARMAC's consultation regarding proposed changes to their consumer and clinical advisory committees.
- Following BCAC's 2018 application to PHARMAC to fund nab-paclitaxel, this was finally referred to their Cancer Treatments Subcommittee in July this year. We provided an evidence update to PHARMAC but four months later we are still awaiting an outcome of this meeting.
- BCAC made a submission to PHARMAC supporting the retention of fulvestrant as a first-line metastatic treatment and pertuzumab as a neo-adjuvant treatment after their proposal to decline funding for these medicines. Our submission also stated that while we had no comment on the decline proposal for lapatinib, two new medicines in the same class (tyrosine kinase inhibitors), namely neratinib and tucatinib, should be funded in the near future.
- BCAC Secretary Fay Sowerby met with the Clinical Directors of Breast Screen Aotearoa and the National Screening Unit to discuss information on risk management and targeted screening to improve prevention and achieve earlier diagnosis of breast cancer. This meeting followed



the distribution of a BCAC discussion document in 2020, *Moving towards personalised screening in New Zealand,* that recognised how we screen, when we screen, with what frequency and what is advised and reported all need renewed focus and input from those leading, managing and participating in New Zealand's screening programmes.

 Enhancing NZ Clinical Trials Project - Fay is a Steering Committee member for the project and Libby Burgess and Terre Nicholson were invited to act as consumer representatives for the focus group. Their work includes feeding into the project from a consumer perspective on better embedding healthcare consumers in the entire clinical trial pathway. The initiative aims to involve consumers in trial design and prioritisation, then to ensure implementation of results and translation into practice.



- There is also work underway to develop a National Clinical Trials Alliance to enhance clinical trial infrastructure and participation in New Zealand. Both Fay and Libby participate in this via a working group, attending workshops to provide feedback on how the Alliance should be shaped and the next steps towards making it happen.
- BCAC provided feedback to the Ministry of Health's consultation on Breast Reconstruction – National guidelines for best practice.
- Libby participated in The Economist's Economic Intelligence Unit online meeting of breast cancer clinicians and patient representatives across the Asia Pacific region to map out a pathway for developing patient-centred diagnosis and treatment pathways for early breast cancer in each country.
- A number of meetings took place with pharmaceutical companies to learn about new products coming to the market, and to encourage companies to apply for registration and funding for key breast cancer drugs in NZ, and to make these products available to patients at affordable prices prior to public funding.
- BCAC collaborated with other patient organisations to promote the New Normal Same Cancer campaign. Due to the disruption of health services during the ongoing COVID-19 pandemic, these organisations realized the growing need to remind and encourage people to contact their health professional to get checks or attend appointments to minimise delays in diagnosis and treatment of cancers.
- BCAC committee members attended conferences and meetings to remain up-to-date with the latest thinking and innovations, many of these "virtually" in the last year as conferences have been forced online due to the ongoing pandemic. These included:

- the Annual Scientific Meeting of Breast Cancer Trials and other online BCT meetings and events
- o the online inaugural New Zealand Familial Breast and Ovarian Cancer conference

- breast cancer webinars run by the European
 Organisation for Research and Treatment of Cancer
- the St Gallen Consensus Conference on Early Breast Cancer Treatment Standards
- the UK National Institute for Health and Care Excellence's new 5-year strategy launch.
- BCAC also attended the foremost international breast cancer research conference, the San Antonio Breast Cancer Symposium in December 2020, via their online programme as consumer advocates, and will do so again in December 2021.

Improving outcomes for Māori and Pasifika women

- BCAC continued to advocate for removing barriers and improving access to breast cancer diagnosis, treatments and reconstruction options for Māori, Pasifika, rural and disadvantaged women.
- Liaised with Māori and Pasifika women affected by breast cancer and related advisory groups.
- Highlighted the poorer outcomes of Māori and Pasifika women with breast cancer and identified opportunities for improvement.
- BCAC committee member Irene Kereama-Royal provided a Māori perspective and advised on matters relating to ethnic equity in NZ breast cancer care.
- BCAC welcomed Maria Marama onto the committee to strengthen our capacity in understanding and acting on ngā take Māori.

Despite the ongoing challenges of Covid-19, BCAC has once again received generous and kind support from a number of organisations and individuals in 2021.

BCAC's relationship with The Good Registry, an organisation that helps people to give charitable donations as gifts, has continued to grow this year. We have been very grateful for the regular donations we have received from the wonderful people of The Good Registry and their 'givers'. A Pfizer grant also enabled BCAC to produce a set of patient videos, *Gifts to the Future, He Koha ā Mua,* in which women with advanced breast cancer could leave a legacy for whānau as well as offering valuable perspectives, tips and messages for others facing a similar diagnosis. 

BCAC Revenue to 31 March 2021





Plans for 2022

FOR 2022, OUR ACTIVITIES WILL INCLUDE:

To make world class detection, treatment and care accessible to all affected by breast cancer in New Zealand

- Continue engagement with decision makers at all levels. Liaise with Ministers, MPs, the Cancer Control Agency Te Aho o Te Kahu and the Ministry of Health to advocate for improved breast cancer screening, precision diagnosis and treatment and supportive care to improve outcomes and equity.
- Raise awareness of new and emerging medicines and the need for increased funding to enable broader and earlier access to treatments that will improve quality and length of life.
- Meet with PHARMAC to champion access to effective and innovative medicines.
- Meet with pharmaceutical companies and encourage them to register their innovative medicines in New Zealand, offer them at affordable prices and free of charge to patients when funding is imminent.
- Review the performance of the Cancer Control Agency Te Aho o Te Kahu and provide feedback and advice where appropriate.
- Consult, engage with, seek advice from and, when appropriate, represent Māori and Pasifika women on breast issues and advocate for actions needed to increase access to services and improve breast cancer experiences and outcomes.
- Increase education and knowledge of breast cancer, treatments, supportive care and emerging clinical trial results by attending and promoting local and international expert meetings and conferences.
- Continue to strengthen networking and collaboration among groups and individuals.

To provide information and support to empower those with breast cancer to make informed choices about their treatment and care

- Widely distribute our updated 4th edition of *Step by Step* to women newly diagnosed with breast cancer.
- Provide information and support for those with early and advanced breast cancer.

- Progress our investigations into the need for Māori-specific resources related to the *Step by Step* support pack.
- Provide up to date information via our website about breast cancer and our advocacy work.
- Communicate with the breast cancer community via our Facebook page and Twitter.
- Continue to support the Metavivors NZ and Metavivors NZ Action Facebook groups and members.
- Distribute news and information via our e-newsletter to hundreds of subscribers.
- Respond to requests for information and support.

To provide a unified evidence-based voice for New Zealanders who have experienced breast cancer

- Raise awareness of advanced breast cancer and the needs of people whose disease is terminal.
- Participate in a wide range of local, regional and national breast cancer-related working groups, committees and organisations.
- Respond to consultation opportunities relating to breast cancer.
- Advocate for timely access to world-class breast care, including diagnostics, treatments and supportive care in New Zealand.
- Promote the uptake of precision tests to ensure acccurate diagnosis and appropriately targeted treatment.
- Support and promote initiatives enabling the early detection of breast cancer such as mammographic screening, breast density reporting and breast awareness by meeting regularly with BreastScreen Aotearoa to encourage continual progress with the National Screening programme, including broadening the eligible age band.
